### II. School Tours

The AF Rhode Island Board toured AF Providence Elementary and Middle at Hartford Avenue. It was the first full day of school for scholars. The board spoke briefly with the two principals and observed classroom instruction. At the completion of the AF Providence tour at 10:45am, the board relocated to AF Iluminar Elementary and Middle for a tour of those schools. Similarly, it was the first full day of school for AF Iluminar and the board had a chance to briefly speak with schools leaders and observe classrooms.

III. Board Discussion on AF Rhode Island Schools, Providence Public Schools and AF Expansion The Board debriefed their experiences and observations on the tours at AF Providence Elementary and Middle, and AF Iluminar Elementary and Middle. Directors noted positive teacher morale, focused scholars, beautiful classrooms, and joy.

Maryellen Butke and Reshma Singh initiated a conversation about AF's expansion in light of the Johns Hopkins Report on Providence Public Schools and the challenges in the Providence Public School system. They want to move forward with the expansion plans RIDE approved in 2016. Mayor Elorza responded noting (1) his responsibility to serve all children in the Providence Public School system and (2) his willingness to find a path forward but without a negative fiscal impact on the Providence Public School System. Dacia Toll shared that the Report was a call to action and the question AF is asking is how we can help? In terms of timing, it is critical for the board to make a decision in September 2019, for a school opening in 2020, because will give AF the runway to get a facility, hire leaders and staff, and do everything else required to successfully open a school.

The board discussed ways to bring AF's professional development, leadership development, and learned best practices with the Providence Public School System. Ms. Toll talked about the strength and positive impact of AF's Partnership work across the country, which involves weekly coaching and curriculum sharing.

Mayor Elorza is aligned with the interest in partnering with the district to share best practices. James Wiley and Maryellen Butke volunteered to be part of a board subcommittee to explore that partnership.

While a majority of board wants to expand by opening an additional school, Mayor Elorza is in the same place he has always been - wanting a fiscal impact study before making any decision. He said expansion depends on where the seats come from. One way forward on the expansion question is to talk to the Commissioner about closing a low performing charter.

At the conclusion of this discussion, Mayor Elorza left the retreat to attend a previously scheduled event.

#### IV. Executive Session

The board entered executive session at 1:15 pm to review the Professional Growth Plans (PGPs) of the principals.

Sarah Blanton is going to help schedule calls with the Regional Superintendents to discuss the PGPs. Macky McCleary, Reshma Singh, James Wiley expressed interested in joining the PGP discussions.

The board debriefed the discussion about expansion and talked about how Directors can better help serve the schools and families.

The Board discussed the Family Handbook template as presented including ways to ensure that it is accessible to all families.

The final resolution before the board involves the expansion of Achievement First. Mayor Elorza referenced the resolution from three years ago that supported expansion but with limitations regarding the financial impact that expansion would have on the district. Mayor Elorza has worked with the State and is pleased to support the expansion. Maryellen Butke and Reshma Singh voiced their appreciation for the Mayor's efforts to find a path forward.

The timeline is aggressive. In voting today, a K-1st grade school could potentially open in August or September 2020. Elizabeth Winangun articulated the need to find a facility, a school leader, and philanthropy.

WHEREAS, the AF Rhode Island Board of Directors held a vote on September 29, 2016, regarding the expansion of AF Rhode Island, and

WHEREAS, the State of Rhode Island approved the expansion of an additional AF Rhode Island K-

8 school in December 2016,

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of AF Rhode Island authorizes Achievement First to move forward in opening a new school serving grades K-8, starting in grades K-1.

BE IT FURTHER RESOLVED, that the Board of Directors of AF Rhode Island hereby authorizes and directs Achievement First Network Support to prepare, execute, and deliver such documentation and to take and carry out any other action required to effectuate the foregoing resolution.

### V. Reports and Business

### A. Principal Report

Kevin Lohela gave a report on AF Iluminar Elementary School. Attendance is 98 percent, student attrition is 0%, suspensions are very low and teacher retention is very high. Org health results are the strongest they have ever been and student achievement, based on RICAS and interim assessments, is strong.

Andrew Walker, principal of AF Iluminar Middle School, gave a report about school culture, the focus on belonging (both scholars and teachers), and the ways in which the schools proactively address student concerns.

Aja Davis was sick and was unable to attend the meeting.

Ashia Parks, principal of AF Providence Middle School, began her report by addressing issues of school culture, especially those named during public comment. The school is not currently meeting her vision of excellence nor is she surprised by the public comments. She expressed the desire for partnership with families and for support from the network

The board asked whether there was a way in which they could help. Ms. Parks said she welcomed help and support and invited the board to the town hall meeting in January with families.

# B. Treasurer Report

Ben Smith shared that, on an operating basis, the four schools are in good financial shape.

The philanthropy need for AF Rhode Island this fiscal year is \$1.2MM and the two resolutions before the board would reduce the current year philanthropy by \$500K by using board designated reserves. The balance sheet will be used in the short term while AF builds a reliable donor base in Rhode Island. Board

members expressed their appreciation for having this discussion so early in the fiscal year and want to revisit at the next board meeting, scheduled for February 5, 2020. John Igliozzi made a motion to postpone voting on the following two resolutions until the next board meeting. Seconded by Percy Ballah. All in favor.

RESOLVED, the AF Rhode Island Board of Directors hereby approves the budget amendment, as presented in Request 1 of the Executive Summary of the Financial Materials.

RESOLVED, the AF Rhode Island Board of Directors hereby approves the requested use of board designated reserves, as presented in Request 2 of the Executive Summary of the Financial Materials.

Victor De La Paz explained the following two resolutions. Resolution 1 addresses a budget revision to the revenue. If the resolution is passed, the budget will be revised. The second request is for a request to use the board designated reserves for an allowable use.

Ben Smith reminded the board that during the budget approval process in spring 2019, AF flagged that there would be a budget reduction request and this is that request.

RESOLVED, the AF Rhode Island Board of Directors hereby approves the budget amendment, as presented in Request 1 of the Executive Summary of the Financial Materials.

[Request 1: In this memo we are asking the AF Providence board to amend the current year revenue budget downwards to reflect an excess philanthropy grant (Private Revenues provided by AF) that was awarded in fiscal year 2019 in the amount of \$184,014. Please see the accompanying reconciliation of prior year results showing that AFRI did not need a \$300,000 grant award and note that AF is only requesting a reduction equivalent to ~60% of the over-payment. Depending on other operating results, this may impact net income in the current fiscal year negatively, and the strength of the balance sheet (cash and net assets) would be used to offset the loss. On an audited basis, AFRI had \$3.26M of cash and \$2.34M of net assets per the audited financial statements on June 30, 2019.]

RESOLVED, the AF Rhode Island Board of Directors hereby approves the requested use of

board designated reserves as presented in Request 2 of the Executive Summary of the Financial Materials.

[Request 2: In addition, we are requesting that board designated reserves be utilized in this current fiscal year for purposes allowed in the board policy in the amount of \$315,986. The AF Providence schools remain in a growth phase, and the addition of a second site this year has placed additional burden on the philanthropy challenge in the region. As a reference point, last year's philanthropy need was \$402,579, and this year it is \$1,266,001. After these two amendments, the philanthropic need for this year will be \$766,001 on a budgeted basis, which still represents a significant YOY increase. As the board knows, we have a limited philanthropic base in RI (less than \$100,000 of the ~ \$400,000 we raised last year came from RI donors), although we are working to build it. Currently, most of the philanthropy we use for our RI schools comes from NY and CT donors. This request would have an impact to net assets as well, in the amount of \$315,986 to the downside.]

# II. Authorize Acceptance of SBA Backed Payroll Protection Program Loan

Victor De La Paz, AF's CFO, gave an overview of the federal PPP loan for which AF Rhode Island has been approved through Washington Trust

The CARES stimulus package authorized support on a first come first served basis and AF Rhode Island received an award in the amount of \$2.3MM. At best, this will be a fully forgivable loan. At worst, it will be a 1% interest loan over a 24 month period.

- The loan is based on employment (209 employees on payroll).
- 75% of that loan must be for payroll costs and the first payment would be due in six months.

The board asked questions of Mr. De La Paz about some of the specifics of the loan and the ways in which it can be spent. The board had a discussion about education revenue this year, next year, related risks, community needs and the impact of this loan.

We, the undersigned, being the directors of AF Rhode Island, a Rhode Island non-profit corporation with a principal office located in Providence, Rhode Island ("the Board"), in

accordance with the bylaws and laws of the State of Rhode Island hereby adopted the following:

WHEREAS: As a result of the COVID-19 pandemic, the Board has been required to seek financial assistance through the SBA backed Payroll Protection Program. Said funds will be used to ensure the continued operation of schools under its supervision.

RESOLVED, that effective immediately, the Board has begun the process of completing the required documentation necessary to apply for the above referenced financial assistance,

RESOLVED, that the Board is authorized to take all reasonable steps necessary to complete the loan application(s) related to the Paycheck Protection Program including, but not limited to, the submission of financial records, tax returns and payroll records.

RESOLVED, that the Board is hereby authorizing Achievement First Chief Financial Officer, Victor De La Paz, to sign any and all documents ancillary to the completion of the above referenced loan application.

FURTHER RESOLVED, that any officer of Achievement First, Inc. and their designees (each an *"Authorized Person"*) is, jointly or severally, authorized and directed, at any time and from time to time, to do such things and acts for and on behalf of the Board as may be necessary or advisable in order to give effect to and, generally, carry out the intent of the foregoing resolution in the name and on behalf of AF Rhode Island, on such terms and conditions and in such form deemed necessary or desirable and approved by such Authorized Person with such changes, modifications and amendments thereto as such Authorized Person may in such person's discretion approve, which approval shall be conclusively evidenced by the execution and delivery of such documents and instruments in writing.

BE IT FURTHER RESOLVED, that the Board Chair is hereby authorized to certify that these resolutions have been duly adopted and that they are in conformity with the Bylaws of this Board.

#### I. Call to Order & Attendance

#### Public: Jillian Fain

Mr. Kevin Lohela spoke about how AF Iluminar Elementary School is taking an individualized approach to working with families. They are creating multiple opportunities and formats for families to give feedback. 97% of families shared that they feel positive about the distance learning program. And, while much of the feedback showed appreciation for the consistency of math and ELA, parents also expressed the desire for it to not to feel stale. Mr. Lohela shared that teachers responded to that feedback by making lessons more creative including virtual field trips and science weather reports, for example.

Mr. Lohela said they are providing individualized support for scholars with paraprofessionals. They've worked to be creative about leveraging the knowledge, talents and creativity of staff, while being flexible about scheduling to ensure scholars continue to receive the services they need. Ms. Aja Davis, principal of AF Providence Elementary, added that some students are getting additional supports, with multiple personalized touch points per day, scaffolding, pulling back or adjusting assignments in any ways that the IEP specifies. She thanked AF's Team Special Services and how they have provided related services like speech or occupational therapy.

To address concerns among the students, Ms. Davis said they are using resources from Yale's RULER program and taking time on conferences to check in on how students are doing and feeling. Mr. Lohela spoke about how they are taking care of the stresses and challenges that the adult team is experiencing.

Ms. Davis applauded the operations team in how they got Chromebooks and mifis to scholars. In a recent staff survey, 100% of the staff at AF Providence Elementary responded positively that their principal, coach or someone at the school cares for them. One of AF's values is Care for the Whole Person and she is proud that her staff feel that way. Teacher retention is strong (85%) and she is fully hired for next year. She noted that AF has been phenomenal in supporting the schools. They are in the middle of a family survey and are working hard to get responses.

Sal Pellerano, Director of School Operations, spoke about the impact that the AF Team and Family Fund which is being raised by AF and disbursed directly to families who need urgent financial assistance. Approximately \$160K has been raised to date, and \$90K has been given out across the network. Some gifts have been one-off and others are recurring donations. Each gift is currently capped at \$500.

At this point in the meeting, Macky McCleary joined the Zoom Room and Mayor Elorza called the meeting officially to order (6:02 pm) with a quorum.

### IV. Reports and Business

Mindy Rice, who will be principal of AF Promesa Elementary School, thanked the board and expressed her gratitude for approving her. She has hired her leadership and 26 of 28 staff members for next year some of whom are coming from AF Iluminar and AF Providence Elementary Schools. She's excited about the diversity of her staff – 40% identify as Black, Latino, multiracial, six are AF parents and there are several men on the team which is not typical for an elementary school.

# A. Facilities Discussion and Possible Action related to the due diligence for the future AF Rhode Island HS

Cassidy McKee introduced David Sweeny, AF's new VP of Facilities. AF Rhode Island will have high school students in 2021 and will need a building to house the high school starting in 2022. There are currently two building opportunities that AF is exploring – one is in Providence and the other would be to expand the site at Garfield Ave. The AF Facilities team wishes to begin due diligence with test kits, site planning, and initial environmental work.

WHEREAS, the AF Rhode Island Board of Directors (the "Board") approved expansion of the AF Rhode Island charter by opening a high school in the fall of 2022, pending approval by RIDE, at its meeting on September 29, 2016;

WHEREAS, the Rhode Island Department of Education approved the expansion at its meeting on December 20, 2016;

BE IT RESOLVED, that the Board approves the due diligence portion of the AF Rhode Island High School expansion project, as presented, for a cost not to exceed \$130,000.

BE IT RESOLVED FURTHER, Achievement First and its designees are, jointly and severally, authorized and directed, in the name of the Board, to submit and execute such documents needed in order to effectuate the foregoing resolution.

### B. Board Chair Report

Mayor Elorza shared summer learning opportunities for Providence students. Without knowing the eventual financial impact of this pandemic, the Mayor is holding to his commitment to investments in youth, such as high quality summer camp, enrichment programs, summer jobs programs (serving 1500-1600 kids), and summer learning programs.

They have asked all service providers to come up with two plans: in-person and virtual. Summer camps can open in June but that is subject to change. The commitment to youth and education, however, remains and they will fight to preserve dollars in the next year's budget.

The board discussed the principal candidate, Mr. Donavan Tracey, for AF Providence Middle School. They felt he was a strong candidate for a variety of reasons, especially his commitment to building strong relationships and his community engagement within and beyond AF. They noted the high leadership turnover at AF Providence Middle School, the challenges a new principal will face, and the way the board can support his success.

RESOLVED, the AF Rhode Island Board of Directors hereby accepts Achievement First's nomination of Mr. Donavan Tracey as principal of Achievement First Providence Middle School effective July 1, 2020.

Following the voting, Mayor Elorza noted Andrew Walker had joined the meeting and could give his principal report. Mayor Elorza had to leave the meeting and passed to Ben Smith to continue to lead the meeting.

Andrew Walker reflected, with gratitude, on his first year as principal of AF Iluminar Middle School. They've been working to provide the same high level of rigor and fun, despite not being in school. Family survey results have been very strong. They're doing regular town hall meetings ("Pastries with the Principal" continues), consistent check points with families, and strong interventions for scholars. They're working on virtual community events including an end of year expedition. They are almost fully hired for next year. He noted two mid-year departures and 100 percent retention of the teaching staff and leadership team.

Mr. Walker said that the Greenfield model helped support strong mindsets around valuing independence. They had operational systems already in place that supported remote learning, self-directed learning. Students already had Chromebooks. Thus, they were able to quickly pivot but despite being relatively well set up, remote learning is challenging so they sought to simplify the program for kids.

### C. Treasurer Report

Victor De La Paz, AF CFO, joined the meeting and gave an overview of the budget process and considerations including an expectation for flat or decreased funding, philanthropy, and many unknowns (costs, transportation, cleaning, and equipment). AF is planning for different scenarios.

Mr. De La Paz spoke about the basis for which the PPP loan was applied for and approved.

The budget assumes flat funding but if revenues decline there are four levers to lean on:

- (1) a cushion from this year based on moderate savings (utilities, transportation, maintenance) despite the spending on technology,
- (2) stimulus funds: Title I and PPP, which is currently a loan,
- (3) balance sheet, which amounts to just under two months of operating expenses,
- (4) mid-year budget cuts.

While on May 19<sup>th</sup>, financials are stable, information is going to change and AF anticipates returning to the board with revisions to the budget at a later date.

RESOLVED, the AF Rhode Island Board of Directors hereby approves the financial report as presented.
