Amistad Academy Board Meeting

Sarah Blanton recorded the minutes. The meeting was called to order at 12:04 pm.

NOTE: This was a joint meeting with all Achievement First school boards.

1. Public Comment

There was no public comment.

2. Discussion of 2020-21 School Reopening Plan

Dacia Toll reviewed the draft plans for the upcoming 2020-21 school year and engaged the board in a discussion about their feedback and questions, especially around the strength and vulnerabilities in the plans, how to address anxiety of staff about returning and how to support students and families who most need in-person school.

The draft plans are influenced by research from public health experts, guidance from local authorities, surveys of students, families and staff, and lessons from other districts around the world who have reopened.

Each of the plans begins with the following guiding principles:

- 1. Safety first
- 2. Family choice
- 3. Prioritize our youngest scholars
- 4. Flexibility
- 5. Strong socioemotional support
- 6. Strong student learning.

Under the AF draft plan, families will be able to choose whether they want their children to learn remotely or in-person and AF is committed to making both options excellent. In Rhode Island, the draft plans calls for kindergarten and first grade returning in person on August 31, with other grades starting remote on that date and returning for in-person on September 15. In Connecticut, all grades will start remote on September 1 or 2 and in-person learning will be phased in starting on September 15. In New York, all grades will start remote on September 1 or 2 and in person will start no sooner than September 15.

Ms. Toll reviewed a sample schedule for in-person and remote, for elementary, middle and high school. She also reviewed the timeline for each state for gathering input on the plans, sharing them with families, collecting responses on whether they want in-person or remote, and school-specific follow up with families.

II. Open Session for Public Comment

There was no public comment.

III. Discussion and Business

A. Principal reports

Ms. Brooke Williams updated the board on the start of the school year which has been going smoothly.

Ms. Williams has hosted two town hall meetings. She reported that parents shared appreciation with the staff but did encourage the school to increase engagement between scholars during Zoom. This feedback was consistent with what the teachers were also focused on.

Ms. Williams discussed student attendance and teacher retention. The school is currently fully staffed. Three teachers are not certified but they have their tests scheduled within the next few weeks. All members of the leadership team returned this year..

Ms. Williams discussed some lessons learned from remote learning last spring including shifting

the remote school day to mirror a regular school day, keeping kids in pods, and grading,

Ms. Christina Ellington, regional superintendent, shared her impressions of the start of the year and how the Amistad Elementary teachers are showing patience and pizazz to help kids enjoy their learning.

Ms. Roseann Basile, Amistad Middle School principal, shared that she's enjoyed meeting the staff and establishing shared commitments to establish a strong vision for school culture. She shared survey feedback which was strong with helpful pushes. That feedback was shared with the staff the next day along with the action steps they were taking in response to the feedback.

Three teachers leftover the summer. Two of the teachers who left were new teachers who left on the first day and the third shared that she was offered another position where she can be 100% remote which was a better choice for her.

Back to school night is approaching and they are hoping to get as many families involved as possible. Ms. Basile plans to implement town halls to engage families.

Finally, Ms. Basile shared that the new teachers are paired with more experienced teacher which helps the transition and provides consistent modeling.

D. Joint High School Committee Report

Jane Levin gave the Amistad High School report noting strong leadership team retention (they lost one member of the LT who is now a principal at another AF school). Ms. Levin reviewed

enrollment, student and staff retention. All students have the technology needed for remote learning.

Seniors are finalizing their college lists. Professional development is continuing for teachers at the same level as it had been prior to COVID and special education services are continuing for scholars.

E. Executive Session – Personnel discussion (interview) regarding the hiring of an interim principal

The board entered executive session at 6:03 pm and invited the following members of the Achievement First staff to join: Sarah Blanton, Brooke Williams, Christina Ellington and Lauren Gemske. Motion by Tyra Smallwood. Second by Lorraine Gibbons.

The board exited executive session at 6:17pm to vote on the resolution for interim principal.

G. Finance Committee Report

Victor De La Paz, CFO, joined the meeting to give an overview of the financials. There is a budget amendment before the board which takes into consideration adjustments to expenses for COVID and remote learning as well as shifts in revenue. The balance sheet shows a strong cash balance because of the PPP loan.

Mr. De La Paz reviewed changes to the PPP loan.

RESOLVED, the Amistad Academy Board of Directors hereby approves the amended budget as recommended by the Finance Committee and prepared by Achievement First for the 2020-21 fiscal year.

Ms. Greenspan welcomed Lashell Rountree to share teacher certification data. Ms Rountree projected 100% certification once all paperwork is processed by the state.

Ms. Greenspan reviewed the CMO evaluation which is required annually by the State. The Conflict of Interest Disclosure Statements must be completed and emailed to Sarah Blanton. Finally, Ms. Greenspan reviewed the following resolution in support of Achievement First's Lead for Racial Equity core value and the resolution passed by the Network Support Board.

WHEREAS, Amistad Academy was founded to address the legacy of racism in public education and to support the young people in New Haven to realize their full power and potential;

WHEREAS, Amistad Academy has entered into an Academic and Business Services Agreement with Achievement First, Inc ("AF"), dated as of July 1, 2020;

WHEREAS, Lead for Racial Equity was defined as the lead core value for AF, but AF has acknowledged that it has not -- and does not currently -- consistently live that value in its schools. While AF has made meaningful progress in some areas, AF has not acted urgently or boldly enough to be consistently anti-racist in its instruction and curriculum, school discipline and student experience, talent practices and policies, family engagement, and decision-making; and

WHEREAS, Amistad Academy, in alignment with AF, aspires to lead the education sector not just in what our scholars achieve but also in the values-based way we operate. We believe that when we know better, we must do better. We are committed to becoming the anti-racist school system and community that our scholars, families, and staff deserve. We believe that we must interrogate our current practices, accelerate change, and institutionalize the equity-based mindsets, policies, and practices that are needed to move us collectively toward that vision.

BE IT RESOLVED, the Amistad Academy Board of Directors hereby affirms that Amistad Academy will uphold the values of Lead for Racial Equity and:

- 1. Vehemently denounce racism and actively work to dismantle it within and outside Amistad Academy;
- 2. Build structures and accountability to ensure all students, families, and staff are treated equitably and feel heard and valued; specifically, work to amplify Black and Latinx voices and perspectives both internally and externally;
- 3. Implement an anti-racist approach to the its beliefs, mindsets, policies, and practices with goals and actions in each of the following areas:
 - Adult culture and inclusive decision-making
 - Student Experience/School Culture (including student discipline policies and practices)
 - Talent (including equitable development, promotion, and compensation)
 - Instructional practices and curriculum
- 4. Instruct the principals of Amistad Academy to report at board meetings on the progress against these commitments, what has been accomplished, how different parts of the Amistad community have been engaged, and what the next phase of the work will be; and
- 5. Ensure all new Amistad Academy priorities and initiatives are developed, launched, and executed with an intentional and embedded focus on Leading for Racial Equity; take any additional steps necessary to ensure Amistad Academy becomes the powerful, anti-racist engine for equity that we were founded to be and that our scholars, families and staff deserve.

II. Open Session for Public Comment

There was no public comment.

III. Introduction to Rich Buery

Dacia Toll and Rich Buery joined the meeting to discuss Ms. Toll's plans to transition out of her role as CEO towards the end of this academic year. She shared that the decision feels right and that AF has been a tremendous joy. She is convinced that this is healthy and right for the organization and feels very strongly that Rich Buery is the leader that will take AF to the next level.

In her introduction of Mr. Buery, she shared his professional experience founding and leading organizations, including the Children's Aid Society and NYC's Pre-K for All initiative. She spoke about his extraordinary people leadership skills and his high standards for the scholars we serve.

Mr. Buery introduced himself by sharing a bit about his background, growing up as the son of a high school teacher in East New York. His history with Achievement First includes watching

Amistad Academy open in 1999 (having been at Yale Law School at the same time as Ms. Toll) and serving as a founding board chair of one of the Brooklyn Charters

IV. Discussion and Business

A. Principal reports

Ms. Rosie Basile, Amistad Middle School principal, shared that with school is transitioning back to remote learning after what she believed was a very productive hybrid learning period. Scholars were able to get much more done and were enjoying being in school.

In mid-December, they will have organizational health data survey results. Preliminary pulse checks have been very positive.

The Dean of Special Services resigned in October which was unanticipated. There is a strong internal candidate for the role. In addition, there should be four special services teachers but they currently only have three. All work is getting done but Ms. Basile noted that the team feels stretched.

"Chapter two," which marked the second phase of the academic year, in which families could opt into hybrid learning or remote, was supposed to have more scholars back in school than chapter one. Ms. Basile is hopeful that when they are able to be back in the building, those scholars will opt into in-person learning.

Ms. Basile said that everyone is working hard and taking feedback well, but they want to continue to improve instruction. There are no issues with professionalism but there are some substantial academic gaps that need to be closed.

She shared tremendous year-over-year gains in student investment survey results. The Network classroom environment walk-through results were up significantly from last year. The staff experience data shows no variation by race.

Her top priority is for scholars to feel cared for and also to maintain a strong adult culture.

Ms. Lauren Gemske, Amistad Elementary School interim principal, updated the board that chapter two was set to begin with 56% of students back in school. Kids were disappointed to go back to remote. It's especially challenging for the younger scholars to be remote.

Organizational health data shows that 100% of teachers said they feel supported by the

leadership team and 90% said they felt they understand their roles and responsibilities. The 10% who were not clear on their roles and responsibilities were teachers who don't have direct classroom responsibilities and indicated they were not clear on how best to support remote instruction.

STEP (reading) test results showed students falling behind where they had been in March. Ms. Gemske discussed how the team is looking to improve remote instruction.

There is a concern about attendance for a subset of students are not regularly attending school. And although kids are happy, they may not be focused and getting work done to the level and degree that the school would like.

Ms. Gemske shared that they are doing very intentional work with scholars around belief and belonging.

Amistad Elementary is soliciting input from staff on programmatic decisions. All voices are being elevated and Ms. Gemske believes they landed in a better place because of the additional input from staff.

B. Joint High School Committee Report

Jane Levin reported from the Joint High School Committee meeting. Unlike at the younger grades, a sizeable number of students who had opted into in-person learning during chapter one decided to be remote during chapter two. At this point, though, they are going fully remote.

Twenty eight students in the senior class have applied to college already, 22 of whom applied early decision. Mr. Obas shared some strong organizational health data but also a concerning area around whether the teachers feel they are adequately preparing the scholars academically. Remote learning is an enormous challenge.

C. Board Chair Report

Ms. Greenspan shared with the board that Elm City is doing renovations on the building that Amistad owns and the Amistad Board is agreeing to guarantee the loan.

WHEREAS, the Amistad Board of Directors (the "Board") are the owners of property located at 407 James Street, New Haven, CT (the "Property"), and is leased to the Elm City College Preparatory Board of Directors ("ECCP");

WHEREAS, ECCP has approved and substantially completed the facilities consolidation and renovation project at the Property;

WHEREAS, ECCP has approved a loan agreement by and between itself and the Charter School Growth Fund ("CSGF") for nine hundred and fifty thousand dollars (\$950,000.00) at a three percent (3%) interest rate, to be repaid on terms described above;

WHEREAS, the loan is predicated on a) a guarantee from Amistad, owner and beneficiary of the improvements, and b) on a management fee subordination agreement from AF Inc.;

BE IT RESOLVED, that the Board hereby agrees to serve as guarantor of the Loan Agreement with CSGF, for nine hundred and fifty thousand dollars (\$950,000.00), binding the Board to the terms and obligations in the Loan Agreement attached as <u>Exhibit A</u>.

BE IT RESOLVED FURTHER, Achievement First Inc., acting through its officers or designees (each an "Authorized Person") are, jointly and severally, authorized and directed, in the name of the Board, to do all such things and acts and to execute and deliver all such applications, documents and instruments in writing and to expend such fees for and on behalf of the Board as may be necessary or advisable in order to give effect to and, generally, carry out the intent of the forgoing resolution including, without limitation, to execute and deliver any instruments and documents required in connection with the Loan Agreement, in the name and on behalf of the Board, on such terms and conditions and in such form deemed necessary or desirable and approved by such Authorized Person with such changes, modifications and amendments thereto as such Authorized Person may in such person's discretion approve, which approval shall be conclusively evidenced by the execution and delivery of such applications, documents and instruments in writing; and BE IT FURTHER RESOLVED, that all actions previously taken by any Authorized Person in furtherance of the foregoing resolutions are hereby ratified and confirmed. D. Finance Committee Report

Pat Sweet reported that the per-pupil funding has remained the same and enrollment is strong. The elementary school is projected to break even while the middle school is facing a small deficit.

IV. Discussion and Additional Business A. Principal Reports

Brooke Williams, principal of Amistad Elementary School, shared that the school is in a hybrid model as of March 2. It has been great to have kids back in the building. They have been very good about wearing masks and following the protocol.

Ms. Williams is hosting an upcoming town hall to engage with families.

She shared some academic data and how they are targeting student needs. Ms. Williams is working with the fourth grade in particular. They are projecting very strong teacher retention (91%) and all leaders are returning next year.

Ms. Rosie Basile, principal of Amistad Middle School, shared that reopening went smoothly with approximately 40% of students back in person which is higher than in the fall. She shared how proud she is of the adult enthusiasm to support scholars coming back to school.

Some parents are ambivalent about sending kids in to school for reasons related to positive experiences with remote learning. Ms. Basile started a weekly progress report to parents that goes out via email.

Org health gains have continued to be significant but she continues to strive for absolute success, not just relative success.

Staff retention is projected to be above 80%.

Ms. Basile spoke about student mental health and the outstanding work of the school social

worker. The team is working collaboratively to share student wellbeing. Students seem to really enjoy being at school especially being at recess.

They are thinking about how to structure the school day next year to provide remediation and the social emotional issues that arise in conjunction with academic difficulties.

B. Joint High School Committee Report

Jane Levin shared that the high school reopened successfully but that only 50 students are in the building attending school in person. Those who do come in person are logging into their Zoom classes for synchronous learning.

Ms. Levin noted the mental health challenges the high school is facing and how the school is actively addressing it.

Attendance has been high and college results are good. She noted a program coming to Amistad High School next fall that provides college level coursework that will automatically provide college credit.

They have started planning for the 2021-22 school year with 100% leadership team retention and 89% projected teacher retention.

C. Approve Healthy Food Certification

Carolyn Greenspan introduced the following resolution.

Pursuant to C.G.S. Section 10-215f, the board of education or governing authority certifies that all food items offered for sale to students in the schools under its jurisdiction, and not exempted from the Connecticut Nutrition Standards published by the Connecticut State Department of Education, will comply with the Connecticut Nutrition Standards during the period of July 1, 2021, through June 30, 2022. This certification shall include all food offered for sale to students separately from reimbursable meals at all times and from all sources, including but not limited to school stores, vending machines, school cafeterias, culinary programs, and any fundraising activities on school premises sponsored by the school or non-school organizations and groups.

The board of education or governing authority will allow the sale to students of food items that do not meet the Connecticut Nutrition Standards provided that the following conditions are met: 1) the sale is in connection with an event occurring after the end of the regular school day or on the weekend; 2) the sale is at the location of the event; and 3) the food items are not sold from a vending machine or school

store. An "event" is an occurrence that involves more than just a regularly scheduled practice, meeting, or extracurricular activity. For example, soccer games, school plays, and interscholastic debates are events but soccer practices, play rehearsals, and debate team meetings are not. The "regular school day" is the period from midnight before to 30 minutes after the end of the official school day. "Location" means where the event is being held.

She discussed student investment data comparing results from the fall to the spring – both of which were strong. She reported that between February and April, the school has seen strong academic

growth in grades K-2. They start state testing in grades 3-4 and are working on preparing the students.

In planning for next year, they are considering how to plan the day to best support students. AF is offering remote summer academy and Amistad Elementary is encouraging everyone to attend.

She shared the very high teacher retention (98%) for next year and how positive that will be for adult and student culture. The board applauded her strong leadership.

Lashell Rountree is currently serving as the interim principal of Amistad Middle School. She shared that she's never seen the adult culture at the school as strong as it is. Everyone has been nimble, accommodating and supportive of one another through the transitions in and out of remote learning.

Students seem happy to be in the building. State testing began this week and everything has gone smoothly. She is hoping for a strong turnout for summer academy and they are encouraging participation.

Ms. Rountree concluded her remarks by acknowledging Rosie Basile's leadership as principal.

Jesse Balis Harris, regional superintendent, spoke about the summer academy which will be virtual and run by the same group that ran NSSI last summer. He also shared with the board that AF Camp is launching this summer with 500 seats available to students across the AF network.

B. Joint High School Committee Report

Jane Levin gave the Joint High School Committee report noting teacher and leader retention. She noted that much of the discussion from the Committee Meeting focused on the senior class and their plans for next year.

She shared that the school is not focused on academic testing, but instead has been about supporting the mental health and sense of safety of the students.

C. Board Chair Report

Carolyn Greenspan updated the board on the loan refinancing. The closing will be Thursday, May 13 and it includes a capital reserve and will put leases into place at the Edgewood and James St buildings.

The board had asked the lawyer to review the contracts for the solar panel project. That has taken place.

She also updated the board on the Amistad Renaming process. After the most recent survey, there was no consensus around a new name. The results showed support for changing the name - 57% of respondents wanted a name other than Amistad. Senior leaders are continuing to work on a strategy to get to consensus. The board will continue to discuss this and revisit in the new fiscal year.

She also shared updates on the Vision Process which has had three summits, each with a different focus. The next meeting is May 27th and everyone is welcome and encouraged to attend.

She introduced AF's new COO, Xanthe Jory. Ms. Jory shared that she is in her second week at AF and shared that her work is going to focus on student enrollment, school operations and facilities. She shared her background in school leadership and operations and hopes to bring both of those lenses to this work. Most recently she worked on the pre-K expansion at the NYC Department of Education.

D. Treasurer Report

Pat Sweet began her report by speaking of the audit firm that has performed the audits and has provided engagement letters to perform the FY21 audit.

On the year to date financials, she shared that all three schools are looking to break even this year. Neil Shah, AF's interim CFO, presented the proposed budget for the 2021-22 school year. He discussed federal stimulus funds and the additive resources we will be able to provide over the next 2-4 years to supplement the educational program. AF is working with principals to determine how they want to allocate those resources.
