## **Principal Reports**

Katie Poynter shared school culture data that shows progress on key data points.

There are five weeks until the SBAC test. The scholars took their first mock test a few weeks ago. From the results, they could identify which students need an additional supports and in what areas. The goal is to improve 10 percentage points.

The second mock test started today. Katie mentioned the outstanding results that Carla Seeger has gotten in her classes. She teaches 6th grade math.

They have scheduled parents meetings this week for scholars who are at risk of failing.

Sarah Lewis was unable to attend the meeting so Carolyn Greenspan shared a report highlighting strong school culture data (suspensions, attrition), especially when looking year over year. Staff retention is very high with 100% of the Leadership Team returning next year.

## Joint High School Committee Report

Jane Levin shared the report from the Amistad HS Committee meeting. 99% of seniors have already received an acceptance to college. Academically, things are going well but they are anticipating the challenge of over-enrollment in the future (unfunded seats, building capacity).

The scholars participated in the March for Our Lives walkout.

## **Board Chair Report**

Carolyn shared that the New Haven Board of Education has designated a representative to join the board.
