Achievement First

Discussion and Possible Action with AF Bridgeport principals, Regional Superintendents and Superintendent

Annedrea Coleman shared an update on AF Bridgeport Middle School and the ways they are trying to bring joy to the school day for students and also for staff. In particular, students are enjoying spirit days and the staff are enjoying food centered events. The purpose is to ensure that students and teachers feel seen, heard and appreciated.

Staffing is a big challenge. Since July, the school has lost 13 staff members but refilled six of those positions. Four of the leadership team members are providing coverage, teaching classes on a daily basis. Ms. Coleman is currently teaching 5th grade science. On a day to day basis, there are 3-4 teacher absences. Deans aren't able to consistently be in classrooms to coach. Teachers don't have time to prep so they have to bring work home. The leadership team is prepping for coverages late at night or before school in the morning.

Many new teachers are not receiving the coaching they normally would. Students are getting acclimated to being in school again and school culture concerns are arising.

The board discussed the reasons for staff departures and whether they were COVID related. Michael Hendricks shared that the middle school has a staffing crisis. It is struggling to operate because there aren't enough adults in the building so teachers who should be teaching three sections, are teaching six. The second major issue is that the leadership team is teaching so new teachers aren't getting feedback and aren't improving. 70% of the staff are new teachers who are teaching the entire day and aren't receiving coaching.

Stephanie Keenoy, Superintendent, shared a proposed resolution that would give the school programmatic flexibility to address the staffing challenges. Currently, the State only allows schools to go remote for COVID related reasons and AF would not go remote unless the State allowed it. AF does not believe going remote is what's best for kids, families or staff. However, it would only be done for the grades or classes where there isn't a teacher for those classes. Students would come back to school as soon as a teacher could be in the building.

One of the potential modifications the school is considering is to increase the number of half days to provide additional professional development. No changes would be made without busing.

The board expressed a desire to receive updates as to any changes made as a result of the resolution below.
